*Summary for obtaining a cultural certificate for  
foreign productions applying for incentive 36.2 of  
the corporate income tax act.*

First additional provision. Cultural certificate for applying for tax incentives\*

## ■ HOW TO APPLY:

In the case of investments referred to in Article 36.2 of the Corporate Income Tax Act 27/2014, dated 27 November, the application procedure and the requirements for obtaining the certificate are as follows:

**A)** The application shall be made on the website of the Ministry of Culture and Sports using the standard model, to be presented with the following documentation:

- 1.** Explanatory memorandum detailing the work produced or to be produced and justifying its eligibility and suitability with the criteria detailed in the application.
- 2.** Credits for the production filmed or to be filmed in Spain.
- 3.** Detailed account of the number of days, dates and locations for filming. In the case of animation, visual effects, postproduction, a preliminary working schedule of times and places where these tasks will be undertaken.
- 4.** Signed declaration verifying the truthfulness of the information supplied in the above-detailed documents.

**B)** The certificate shall be issued when the application obtains the minimum score required, in accordance with the scoring detailed in the annexe below.

In the area of action of the Instituto de la Cinematografía y de las Artes Audiovisuales (Institute of Film and the Audiovisual Arts), hereinafter ICAA, the resolution by which the cultural certificate is issued or refused shall conclude the administrative proceedings and the interested party shall be notified within a maximum period of one month from the date of the application. After this period, if the resolution has not been notified, it will be understood that the application has been approved.

The corresponding authority of the Directorate-General of ICAA may revoke the cultural certificate issued if it is proven that the titleholder does not fulfil the criteria under which it was issued, whether it be the proceedings for obtaining the certificate of nationality or qualification of the production, when such proceedings are required, or, otherwise, the process of verification of fulfilment of the corresponding obligations to be undertaken.
